

Special Terms and Conditions for YouTube Premium

Telenet (Telenet BV, with registered office at 2800 Mechelen, Liersesteenweg 4, RPR Antwerp, Mechelen division, VAT BE 0473.416.418., Tel: 015 66 66 66) , sells the YouTube Premium service as a partner of **Google Ireland Limited** (Google Ireland Limited, established at Gordon House, Barrow Street, Dublin 4, Dublin, Ireland, Tel: 080058142). If you subscribe to YouTube Premium through Telenet, you also become a customer of Google Ireland Limited.

These special terms and conditions for YouTube Premium apply to customers who subscribe to YouTube Premium through Telenet, next to the general terms and conditions of Telenet and the YouTube Premium terms and conditions (see https://www.youtube.com/t/terms_paidservice?chromeless=1#premium)

In the event of contradictions or inconsistencies between the various terms and conditions, the following hierarchy (whereby the higher placed documents have priority over the lower placed documents) apply: (i) special terms and conditions for YouTube Premium; (ii) YouTube Premium terms and conditions and (iii) general terms & conditions of Telenet.

To use YouTube Premium, you need a Google Account. You can create this account when activating the service. After completing your order, you will automatically receive instructions on how the activation process works. These instructions will be sent by email by Telenet.

Do you already have a Google Account with an active YouTube Premium subscription? By accepting these terms and conditions, you agree to enter into a new agreement, and you acknowledge that any promotional offers associated with YouTube Premium are non-transferable.

Log in with your current Google Account to activate your new YouTube Premium subscription. This allows your existing subscription to be cancelled and prevents double charges. From that point on, you will no longer pay Google directly but will instead be billed via your Telenet invoice. For all questions regarding billing of your existing YouTube Premium subscription by YouTube, please contact YouTube directly.

YouTube Premium via Telenet has a minimum subscription period of one (1) month. After that, you may cancel your YouTube Premium subscription at any time. You can do so easily through MyTelenet.

YouTube determines any applicable price changes in accordance with the law. If YouTube changes the price of your subscription, Telenet will notify you at least one (1) month before the new price takes effect. You are free to cancel your YouTube Premium subscription before this change takes place, in accordance with the terms as described above.

Google Ireland Limited (1) manages and is responsible for the YouTube Premium app; and (2) is the data controller and therefore jointly responsible for processing your personal data in order to provide the YouTube Premium service.
