Our shared commitments

Through this Charter, Telenet group and its suppliers commit to:

Climate change mitigation

- Setting near-term emission reduction targets by 2030 and achieving net-zero emissions by 2040.
- Maintaining a transparent CO2e inventory, covering Scopes 1, 2, and 3 in line with the Greenhouse Gas Protocol.
- Developing a carbon transition roadmap, including initiatives such as renewable energy adoption, electrification of operations, and reducing product and transportation emissions.
- Implementing new technologies and sustainable business practices to minimize environmental impact.

Climate change adaptation

- Identifying and mitigating climate risks in products and services provided to Telenet group.
- Strengthening resilience within operations and supply chains to prevent service disruptions due to climate-related factors.
- Developing proactive action plans to address identified risks.

Energy management

- Reducing overall energy consumption of supplied products and services.
- Enhancing energy efficiency in hardware, software, and operational processes.
- Setting measurable energy efficiency goals and tracking progress.

Transparency & progress tracking

To ensure continuous improvement, Telenet group and its suppliers will:

- Discuss progress made on environmental sustainability as part of the annual supplier review meeting.
- Share your carbon inventories, targets and progress made against the emission reduction targets on an annual basis, based on a standard template that will be provided by the Telenet Sustainability Program Office.
- Assign dedicated points of contact to facilitate collaboration and knowledge sharing.
