## **Kotjobs - Promotional Terms and Conditions**

**ARTICLE 1 - Introduction** 

TELENET BV (trading under the trade name TELENET), whose registered office is at Liersesteenweg 4 in 2800 Mechelen, with CBE number 0473.416.418 (hereinafter "Telenet"), is organising a promotion under the name 'KOTJOBS' (hereinafter the "Promotion").

These regulations lay down the participation and other conditions applicable to this Promotion (the "Promotion Conditions"). Additional guidelines or instructions (e.g. given via the Action Form) form part of the Action Terms and Conditions.

ARTICLE 2 - Acceptance

Mere participation in the Promotion implies acceptance of these Promotion Terms and Conditions without any reservations. No dispute in this regard will be taken into consideration.

**ARTICLE 3 - Participants** 

Participation in the Promotion is open to students who use/have used Telenet's Internet and who are not acting in the context of their professional activity (hereinafter, "Participants"). Employees/agents who have participated in the creation of the Promotion cannot be Participants. Minor Participants can only participate with the consent of parents or guardians.

Each Participant can participate in the Promotion only once.

The Participant must have fulfilled all his/her obligations to Telenet and may not have any payment arrears with Telenet.

Telenet can exclude a person from participation in the Promotion at any time in the event of breach of any of these Promotion Terms and Conditions or in the event of abuse, deception or participation in bad faith in the Promotion.

## ARTICLE 4 - Conduct of the Promotion

Participants can take part in the Promotion via the action form on telenet.be/student

a) During the period from 21/08/2023 (09:00) to 08/10/2023 (23:59) (hereinafter, the "Campaign Period"), the Participant performs one of the following assignments (hereinafter, "Kotjobs"), using the tools provided by Telenet and in which only the Participant himself is visible or audible:

o Micro-influencer on Tiktok: the Participant creates a video about the Telenet kot offer with Telenet's Tiktok audio and tags Telenet;

o Micro-influencer on Instagram: the Participant makes a nice Instagram Story about the Telenet kot offer with Telenet's filter and tags Telenet;

o Micro-influencer on Twitch: the Participant advertises the Telenet room offer on his/her green screen;

o Poster model: the Participant creates his/her own advertising poster about the Telenet room offer using Telenet's tool and hangs it up in front of the window of his/her room;

o Voice over radio: the Participant makes his/her own advertisement about the Telenet room offer with a voice recording.

The Participant must also comply with the further instructions given by Telenet regarding the content of the advertisement so that the creation of the Participant complies with the obligations of the Economic Code in this respect.

b) The Participant completes and forwards, also within the Action Period, the action form - available on telenet.be/student.

c) The Participant sends the proof of performance of the Kotjob (i.e. screenshot, photo or voice recording) and - in the case of minor Participants: the 'Declaration of transfer of rights regarding portrait rights' signed by the parents/guardian - to kotjobs@telenet.be, also within the Action Period.

d) If Telenet judges that the participation meets all the aforementioned conditions, the Participant will receive a TakeAway discount code by email within 5 working days:

o Micro-influencer on Tiktok: €10 discount

o Micro-influencer on Instagram: €10 discount

o Micro-influencer on Twitch: €5 off

o Poster model: €10 discount

o Voice over radio: €15 off

The discount code is valid only once, cannot be paid in cash or exchanged. The discount code is indivisible and must be accepted as such. It may not be resold to third parties. If the discount code does not work or there is any other question regarding the operation of the discount code, the Participant must contact TakeAway.

ARTICLE 5 - Liability

Telenet cannot under any circumstances and on any legal basis be held liable by the participants for any disadvantage or damage of any kind suffered in the context of the Promotion, except in the case of intent or gross negligence on the part of Telenet.

ARTICLE 6 - Processing of personal data

The personal data communicated by the Participant through registration on telenet.be/student and participation in the Promotion will be included in the files of Telenet, responsible for processing. All information regarding the processing of personal data by Telenet can be read in the Telenet Privacy Policy.

By communicating his/her personal data, the Participant declares that the data provided are truthful, correct, complete and up-to-date. Telenet only processes the personal data within the framework of this Promotion.

In order to participate in this Promotion, the Participant must give his unconditional consent to the publication and use of his name and entry on any media channel. The Participant waives all rights and compensation in this respect. More information on the transfer of portrait rights can be found in the document made available in the online registration form at telenet.be/student.

The Participant has the right to ask Telenet to view, correct, delete or transfer the personal data relating to him/her. The Participant can exercise these rights via My Telenet (only possible for Telenet customers) and the Telenet shop points. In the shop points, one must first identify oneself by means of his/her identity card.

These Terms and Conditions are subject to Belgian law and any dispute relating to its interpretation or application falls within the jurisdiction of the courts of the judicial district of Antwerp, Mechelen Division.
