

## **Kotjobs - Promotional Terms and Conditions**

### **ARTICLE 1 - Introduction**

TELENET BV (trading under the trade name TELENET), whose registered office is at Liersesteenweg 4 in 2800 Mechelen, with CBE number 0473.416.418 (hereinafter "Telenet"), is organising a promotion under the name 'KOTJOBS' (hereinafter the "Promotion").

These regulations lay down the participation and other conditions applicable to this Promotion (the "Promotion Conditions"). Additional guidelines or instructions (e.g. given via the Action Form) form part of the Action Terms and Conditions.

### **ARTICLE 2 - Acceptance**

Mere participation in the Promotion implies acceptance of these Promotion Terms and Conditions without any reservations. No dispute in this regard will be taken into consideration.

### **ARTICLE 3 - Participants**

Participation in the Promotion is open to students who use/have used Telenet's Internet and who are not acting in the context of their professional activity (hereinafter, "Participants"). Employees/agents who have participated in the creation of the Promotion cannot be Participants. Minor Participants can only participate with the consent of parents or guardians.

Each Participant can participate in the Promotion only once (and thus receive a discount code worth 100 euros from TakeAway a maximum of once).

The Participant must have fulfilled all his/her obligations to Telenet and may not have any payment arrears with Telenet.

Telenet can exclude a person from participation in the Promotion at any time in the event of breach of any of these Promotion Terms and Conditions or in the event of abuse, deception or participation in bad faith in the Promotion.

### **ARTICLE 4 - Conduct of the Promotion**

- 4.1. During the period from XX/08/2023 (09h00) to 08/10/2023 (23h59) inclusive (hereinafter, the "Promotion Period"), the Participant performs a creative job advertising the Telenet kot offer (the "GoLoco Kotjob").

For example:

- o The Participant creates an advertisement for the Telenet Kotaanbod on every window in his/her dorm;

- o The Participant makes a cardboard spinner and stands in front of his/her student dorm with the message "My student room has superfast internet from Telenet";
- o The Participant makes his/her own song about the Telenet kot offer and sings it in a Karaoke bar full of students;
- o The Participant goes all out with a Telenet (fake) tattoo.

When performing the GoLoco Kotjob, the Participant must:

- (i) advertise the Telenet kot offer in a positive, correct and non-misleading manner, without referring to or comparing it with the products/services of other companies, or making negative/harmful remarks about Telenet or other companies, and - in general - comply with the obligations of the Economic Law Code; and
- (ii) clearly state that he/she is advertising for Telenet. If the Participant takes a video/photo and shares it on his/her social media channels, he/she must visibly add the hashtag #advertising; and
- (iii) comply with any further instructions that Telenet might provide regarding the content or form of the GoLoco Kotjob.

- 4.2. The Participant completes and forwards, also within the Action Period, the action form - available on [telenet.be/student](https://telenet.be/student).
- 4.3. The Participant sends the proof of performance of the GoLoco Kotjob (i.e. screenshot, photo or voice recording) and - in the case of minor Participants: the 'Declaration of transfer of rights regarding portrait rights' signed by the parents/guardian - to [kotjobs@telenet.be](mailto:kotjobs@telenet.be), also within the Action Period.
- 4.4. The contest consists of making a creative advertisement for the Telenet Kot offer (Superfast, unlimited internet in kot at 25 Euro per month). Each week the entries will be checked for originality. Each week of the contest, a winner will be selected from all participants of that week.
- 4.5. In the absence of valid Entries (and thus Winner) in a specific week, the TakeAway discount code worth 100 euros from that week will be awarded to the Entrant with the second most original valid Entry from the previous week.

The discount code is valid only once, cannot be paid in cash or exchanged. The discount code is indivisible and must be accepted as such. It may not be resold to third parties. If the discount code does not work or there is any other question regarding the operation of the discount code, the Participant must contact TakeAway.

#### **ARTICLE 5 - Liability**

Telenet cannot under any circumstances and on any legal basis be held liable by the participants for any disadvantage or damage of any kind suffered in the context of the Promotion, except in the case of intent or gross negligence on the part of Telenet.

## **ARTICLE 6 - Processing of personal data**

The personal data communicated by the Participant through registration on [telenet.be/student](https://telenet.be/student) and participation in the Promotion will be included in the files of Telenet, responsible for processing. All information regarding the processing of personal data by Telenet can be read in the [Telenet Privacy Policy](#).

By communicating his/her personal data, the Participant declares that the data provided are truthful, correct, complete and up-to-date. Telenet only processes the personal data within the framework of this Promotion.

In order to participate in this Promotion, the Participant must give his unconditional consent to the publication and use of his name and entry on any media channel. The Participant waives all rights and compensation in this respect. More information on the transfer of portrait rights can be found in the document made available in the online registration form at [telenet.be/student](https://telenet.be/student).

The Participant has the right to ask Telenet to view, correct, delete or transfer the personal data relating to him/her. The Participant can exercise these rights via My Telenet (only possible for Telenet customers) and the Telenet shop points. In the shop points, one must first identify oneself by means of his/her identity card.

Under no circumstances will complaints be dealt with orally (e.g. by telephone). Complaints submitted outside the deadline or which have not been drawn up in writing will not be dealt with.

## **ARTICLE 8 - Miscellaneous**

Telenet reserves the right to change, postpone, shorten or withdraw the Promotion or any part thereof if circumstances so require. Telenet cannot be held liable for this.

Printing, spelling, typesetting or other errors cannot be invoked as grounds for any obligation whatsoever.

These Terms and Conditions are subject to Belgian law and any dispute relating to its interpretation or application falls within the jurisdiction of the courts of the judicial district of Antwerp, Mechelen Division.
